The aim of this work is to develop an Electronic Document Tracking System (EDTS) to improve productivity amongst Core administrative personnel, The EDTS that would be developed in this project would be a web application that is able to manage the creation, and movement of files from desk to desk of personnel who work on them. The system would be developed with HTML,CSS,JAVASCRIPT,PHP,MYSQL after establishing vital functional and non-functional requirements and detailed workflows Document, such as, reports, decisions, etc can be processed and tracked by the system in real-time. Furthermore, the system helps in tracking and provides location information. The system is interactive and usable and able to improve file management and productivity in University administrative operations which would eliminate the stressful nature of manually filing and tracking documents. A file tracking and document tracking software was launched by in 2013. The software is a userfriendly barcode-based tracking system. Information and Data Exchange Advanced System (IDEAS) is a file tracking system developed using Free and Open Source Software (FOSS) by the National Informatics Centre (NIC) in Kerala, India. It is developed as a web application and its purpose is to keep track of files coming into a government office (that is, citizens' petitions). Due to its intuitive web interface, government officers are able to easily record or query information about the petitions or files received within their respective offices through the medium of the Internet. Also, users which include both citizens and officers alike can track the movement of files making the system a transparent one. The drawback of this particular system is that it is built to serve files in government offices and not necessarily Universities or other institutions of higher learning.

Another similar system is one developed by a of NIC; India called division "Department of Personnel and Training". The system was developed as a web application for the government of New Delhi. It is used to create, send and track government files (receipts). Similar to IDEAS, the system allows users to track the movement of important files in the process of decision-making. The drawbacks of this system include: security - in any possible hacking situation, all the files can be easily manipulated; also no activity log is implemented for tracking files; the system is platform dependent -runs on a Windowsbased server (IIS) and requires proprietary databases as backend.

The implementation language is HtMl,CSS,JAVASCRIPT,PHP,MYSQL. In addition, Infotronic Systems for instance have developed a file tracking system that employs Radio Frequency Identification (RFID) technologies. The rationale behind the development of the application is for ensuring that existing files are secure. Each file, in file storage (room) receives a RFID file tag label, depending on the file type. The tag contains the name and other related information, including a unique file number. In the file storage door an RFID security gate (sensor) is implemented so that whenever someone takes a file from the file room and tries to go out without proper clearance, an alarm is triggered and such a person is accosted by security guards on duty. The system is very powerful especially for securing files but the same cannot be said for it being used for arranging or searching files. This RFID-based tracking system can also be expensive to implement particularly by a tertiary institution. The costs include those of buying sensors, label tags, and other essential accessories. This can be a draw back in some respect. Putting it all in perspective, we identify that several tracking systems exist that are being used outside the context of learning institutions like Universities. Such systems despite their merits also have drawbacks that make them unsuited for tertiary institutions. A file tracking system that takes the identified drawbacks into consideration, while also targeting tertiary institutions, is desirable. Companies need to control and manage the life cycle of electronic documents. And one of the answers is to track and trace electronic documents.

Locating files is one of the greatest problems in universities nowadays. Time is wasted archiving or searching files, energy is wasted chasing misplaced files, deadlines are missed and sometimes files are lost. Seeing these problems, an application was developed to make a system for file tracking that will solve all of these problems in the best proper way. 2.2 Types of Tracking System

According to Milton Kazmeyer (autotracken.com 2015) there are various types of tracking system of which makes tracking easier thanks to the advance technology available at our disposals of which the following are inclusive

2.2.1 **RFID**

Radio frequency identification is a tracking technology used in many fields. RFID tags consist of an antenna capable of sending and receiving a radio signal, and a small chip containing the broadcast information. In passive tags, once the device receives a radio signal, the tag uses the energy provided to broadcast a weak response. Active tags contain an integral power source to boost signal strength and range, and are more suited to outdoor tracking. Long distance RFID tracking is directional in nature, meaning that the user can determine the approximate direction and range of the tracked item.

2.2.2 GPS

The Global Positioning System has also found use in tracking devices. GPS trackers contain a GPS receiver, allowing the device to determine its approximate position, as well as some sort of mechanism to allow it to report that data. This commonly takes the form of a radio transmitter or cellular link, but survival GPS locators used in planes and ships often include a satellite receiver for worldwide reach. These devices are bulkier

and more expensive than RFID tracking solutions, but they feature much greater range as well as the ability to pinpoint the tracked person or item instantly from a great distance. When choosing GPS tracking systems, it's important to understand the basic types of GPS tracking systems and how they work. Below are four (4) common types of GPS tracking systems.

1. Hardwired GPS Tracking Devices

Hardwired GPS tracking systems are typically used in vehicles. These GPS tracking systems utilize the power of the vehicle's battery for operation. With the brain of the unit hidden under the hood or your dashboard, these GPS tracking systems sometimes come with antennas that must be attached to the vehicle

2. GPS Loggers

GPS loggers are GPS tracking systems that are used to record information to be retrieved at a later date. For example, a GPS logger can be used to track a vehicle or a shipment, but the information cannot be retrieved from the GPS tracking system until it is manually uploaded to a computer. These are also known as passive GPS tracking systems.

3. Personal GPS Trackers

Personal GPS trackers are GPS tracking systems which look like small beepers or cell phones. They're designed to be handheld, clipped to a belt, or tossed in a purse for individual use. GPS tracking systems for personal use are often purchased for the purpose of personal protection for adults and children. Many personal GPS tracking systems include a panic button for quickly alerting family or authorities in emergency situations.

4. Real-Time GPS Trackers

Real-Time GPS trackers are GPS tracking systems which continuously

transmit information so that users can track their location all the time. Real time GPS tracking systems are highly-sophisticated and require the use of tracking services and GPS tracking software. With real time GPS tracking systems, satellite mapping is used to show the location of the GPS tracking devices.

2.2.3 Geofencing

Geofencing is a more passive form of tracking, and can use RFID or GPS technology. In this system, instead of constantly reporting its location, the tracker contains a receiver that can detect its current location by GPS or by proximity to a radio scanner. If the tracker leaves a designated area, it can trip an alarm or report the violation via a transmitter. One example of this type of system is loss prevention scanners at retail stores, which set off an alarm when an active tag enters their scanning range. Tracking devices for children also use this technology, sending distress signals if they leave designated areas such as home or school outside of approved hours

2.2.4 Internet Tracking

Another method of tracking helps the owners of laptops and other portable computing devices track and recover stolen hardware. Many portable computers feature an optional tracking system in the BIOS that, if activated, can report to central servers whenever the device has a connection to the Internet. This can provide IP information, wireless data for geographic triangulation, and some programs even feature the ability to eavesdrop on browsing Internet thieves' communications, allowing the user to gather the data necessary to identify the perpetrator and recover their equipment.

2.2.5 Radio Tracking

By adding a power source to a RFID tracker, you can greatly increase the range its signal will travel. These "active" trackers can respond to a wide-band scanning signal, or you can set them to go off periodically for long-term tracking purposes. A common use of this type of tracker is in the field of biology, when scientists tag animals for the purpose of tracking their behaviors or monitoring their health. This type of tracker is easy to implement, but it only provides a directional signal, requiring triangulation and estimation of the signal strength to provide a rough location of the device.

2.2.6 GPS and Satellite Tracking

The advent of the Global Positioning System has led to the development of incredibly accurate tracking devices. A GPS receiver compares signals from a network of satellites overhead to pinpoint its location to within a few meters, providing real-time positional data. Paired with a satellite radio, this can allow a tracking device to report its location anywhere in the world almost instantly, making it a valuable tool in rescue operations. Survival beacons and personal tracking devices often

incorporate GPS technology to speed rescue operations, and many cell phones contain GPS trackers to help authorities locate 911 callers in an emergency.

2.2.7 Cell-Phone Triangulation

Even if your cell phone is not GPS enabled, it may contain technology designed to help the provider track the device. If you need to call for help in an unfamiliar location, 911 services can contact your provider and identify which cell towers can pick up your phone's signal. By comparing the signal strength at each of these known locations, they can estimate your phone's approximate location, which may be enough to direct

emergency services to your location. This type of tracking is not as effective in urban environments, however, where signal clutter and echoes from buildings can make it difficult to pinpoint a location to within a few blocks.

2.4 Qualities of a good file tracking system

A document management system (DMS) is a system (based on computer programs in the case of the management of digital documents) used to track, manage and store documents. This system should be capable of keeping a record of the various versions of the documents created and modified by different users (history tracking).

Document management software makes it easy for businesses to combine paper and digital files and store them; physical documents or paper files are scanned and digital formats are imported. File formats supported can range from Word documents, Excel spreadsheets, PowerPoint presentations, PDF files, etc.

Document Management processes are essential to ensure statutory or regulatory compliance, such as tax declarations, conformation to various standards, such as ISO, FDA, etc. Such requirements demand easy traceability of documents and audit trail of document creation, access, modification, approval and submission.

Document management is essential in all sectors: Commercial Businesses, Banking, Non-Banking Finance & Insurance, Government & Non-Government, Education, Healthcare, Research & Development, Construction and many more.

In this context 'documents' are any of a myriad of information assets including images, office documents, graphics, and drawings as well as the new electronic objects such as Web pages, email, instant messages, and video.

2.6 Empirical review

Edem and Onwuachu (2014) Developed an Electronic file monitoring system that illustrates how documents in an organization, most specifically the University can be monitored. The University of Port Harcourt

was used to implement this monitoring system. The system is developed with object oriented methodology and implemented with Java programming and Microsoft SQL server. The result of the developed system shows a simple and effective graphic user interface, ensuring privacy for users and effective document monitoring.

Tariq et al (2015) developed and implemented a file tracking-system for the University of Kashmir. It explains design, development, and implementation strategy that can be adopted to implement a webbased file-tracking system for University of Kashmir. A model design of the web based file-tracking system was implemented in Microsoft Technologies using ASP.NET with client and server-side programming for web forms, reports and backend processing performed in C#.NET. MS SQL Server was used as a backend database. HTML, CSS and XML, JQuery, and AJAX was used to make the design appealing.

In 2012, L.M Perocho designed a document tracking system for a medical centre using waterfall model. He automated the document monitoring system using barcodes. The chief of hospital is the major server controller of the system. All types of document enter the system. Hence all communications from within the different section/department or other government agencies are easily monitored or trapped. The hospital as developed by National Informatics Irfan et al (2010), developed file tracking system that offers visibility of the file movement throughout the file approval process. There was no additional client application or software required to be installed as the system is integrated with Lotu.

Delhi, (2010) worked on File Tracking System is web based application to monitor the pendency of receipts and files and assist in their easy tracking. The application was developed by National Informatics Centre (NIC), based on the Central Secretariat Manual of Office Procedures (CSMoP) of the Department of Administrative Reforms & Public Grievances (DAR&PG). It is an integrated package which has features right from diarizing of receipts/files, updating its status, opening of new files, tracking the movement of the files, dispatch of letters/files and finally records management

3.0 Methodology

3.1 Approach for the Development of File Tracking System

3.2 Problem identification

The first phase of SSADM deals with the identification of the existing problems in the old system that actually led to the

3.4 Analysis of the proposed system

Clerks and secretary on the other end serve as the security field agents that work so hard to ensure that files are maintained and do not fall into the wrong hands.

However, it is difficult to find an effective tracking system for the clerks to be able to locate files and keep records of files between the point of creation to the point of processing and finally the point of storage. This is one of the major weaknesses in our organizations aside from storing some incomplete processed files, which this research will help to eliminate entirely.

3.6 Problems of the existing system

These are limitations of the old system that led to the development of the new system in the first instance.

- a. Poor processing speed: The existing system collects excess data in a single file which contributes to poor response time of the system.
- b. Safety of the security processed file is not guaranteed: Normally, it is counterproductive for a file to be lost in the course o it being processed and ready for storage.
- c. Poor database management: The existing system uses distributed database model which sometimes encourages data replication.
- d. Loss of files: The existing system is related with easy loss of files, because most files are kept in a cabinet or shelves which can easily be ravaged by rodents that won't spare the files saved which would lead to loss of files.
- e. Poor funding of tracking scheme: For this reason, some of the working

equipments are poorly managed and lack adequate maintenance. Unqualified staff people are hired because they are willing to take whatever they are paid. No good tracking materials for effective discharging of duties.

How can files be tracked effectively when the present system employed does not allow for standard functioning parts.




Fig 3.1 Current Manual File Tracking System Flow Diagram




FIG 4.1 THE PROPOSED SYSTEM FLOWCHART




FIG 4.2 ADMIN WINDOW FLOWCHART DIAGRAM




FIG 4.3 OVERALL DATA FLOW DIAGRAM (ODFD) OF THE NEW SYSTEM

The system is designed to be user friendly. Any individual who has a basic knowledge of internet browsing/how to operate a computer system can use this application without much stress. All the same users need to have to use the keyboard, how to type in a word processing environment.

Knowledge of How to use ones mobile phone to browse is another advantage because the software does not require much training.

5.1 Summary

Locating files is one of the greatest problems in universities nowadays. Time is wasted archiving or searching files, energy is wasted chasing misplaced files, deadlines are missed and sometimes files are lost.

Sometimes there is need for a file to go through several personnel before it can be rendered acceptable. There are however drawbacks in transferring these files from one desk to another such as getting these files missing or forgetting to document the transfer. Seeing these problems, an application was developed to make a system for file tracking that will solve all of these problems in the best proper way. This will considerably reduce the paperwork and save ones precious time.

5.3 Recommendation

In future, the designed file tracking system may be scaled and enhanced in various ways which can lead the University to paperless egovernance system where in digital files will be used instead of traditional paper based files. Email and or SMS notifications can be sent to file owners notifying them of the status and progress of their files. Mobile apps can be developed to allow officers to view /work on files remotely as well as allow the file owners to monitor the status of their files. Digital signatures can be added to files for the purpose of security and encryption.

5.2 Conclusion

This project has discussed the design and implementation of a web-based file tracking system. The system is designed primarily to track files, especially in an institution. Such a system to the best of our knowledge has not been created for tertiary institutions. To improve on the work however, a pilot study as well as a usability study will be conducted in future work. The feedback from these exercises will be used to improve on the overall features of the system.
