## A Critical Analysis of the Sustainable Development Goals (SDGs) and their Implementation in Least Developed Countries (LDCs)

### **Abstract**

The Sustainable Development Goals (SDGs) were adopted by the United Nations in 2015 as a universal call to action to end poverty, protect the planet and ensure peace and prosperity for all. The 17 SDGs and their 169 targets are designed to be achieved by 2030, with a focus on leaving no one behind. However, the implementation of the SDGs in Least Developed Countries (LDCs) has been slow and challenging. This article provides a critical analysis of the SDGs and their implementation in LDCs, highlighting the challenges, opportunities and recommendations for improvement. The argument of this study is that while the SDGs provide a framework for sustainable development, their implementation in LDCs requires a more nuanced and context-specific approach that takes into account the unique challenges and opportunities facing these countries. This article draws on a range of sources, including academic literature, policy reports and data from international organizations.

### **Introduction**

There are currently 44 economies designated as Least Developed Countries by the United Nations including countries in Africa, Asia, the Caribbean and the Pacific.

These countries face significant challenges in achieving the SDGs due to their limited resources and limited infrastructures as well as their economic vulnerabilities. Despite some significant progress in recent

years with many countries experiencing rapid economic growth as well as improvements in human development outcomes, most of these LCDs are still struggling to recover from trade tensions, rising debts, conflicts and geopolitical strains.

The implementation of the SDGs in Least Developed Countries has been hampered by considerable development challenges such as poverty, inequality and limited access to basic services like healthcare, education, etc. and much work still remains to be done in order to achieve the SDGs in LCDs.

The progress of the SDGs implementation globally can be ascertained from a look at the following sectors of the economy:

**Economic Growth and Employment:**

LCDs experienced a sharp decline in real GDP growth in 2020 due to the Covid-19 Pandemic, but it recovered to 3.8% in 2021, 4.6% in 2022 and 5.5% in 2024. The global unemployment rate has rebounded, but women and youth continue to experience higher unemployment rates. The NEET (Not in Education, Employment or Training) rate for young people remain high at 21.7% in 2023. (ILO Report, 2022), (UNDP Report, 2022)

**Finance and Investment:** The annual SDG investment gap in developing countries is

estimated to be around \$4 trillion. To meet the SDG investment needs by 2030, an additional \$30 trillion of investment is required over the next eight years. (World Bank Report, 2020)

Remittances have been a crucial source of external finance for developing countries with a growth rate of 8% in 2022 reaching \$6.47 billion. Government revenue accounted for approximately 33% of Gross Domestic product (GDP) on average with an overall tax burden of 25% of GDP among advanced economies and 18% of GDP among emerging markets and developing economies. (IMF Report, 2020)

**Official Development Assistance (ODA):**

Development assistance flow reached a new peak of \$223.7 billion in 2023 representing 0.37% of Development Assistance Committee (DAC) members' combined gross national income. (OECD Report 2020, 2022)

**Global Foreign Direct Investment (FDI):**

FDI flows showed a strong rebound in 2023, reaching an estimated \$1.37trillion. (UNTAD, 2023)

**Technology and Infrastructure:** Fixed broadband subscriptions continue to grow, reaching 10 subscriptions per 100 inhabitants in 2023 globally. However, low income

countries still lack infrastructure and affordable prices. Approximately 67% of the world's population or 5.4 billion people were online in 2023, representing a growth of 4.7% since 2022. (UN Report, 2022).

**Data Monitoring and Accountability:** The number of countries with national statistics legislation compliant with the fundamental principles of official statistics increased to 159 in 2023. Moreover, International funding for data and statistics decreased to \$542 million in 2022, a decline of 16% since 2015. (UN Report, 2022). Overall, while LDCs have made some progress towards achieving the SDGs, considerable challenges remain. It is essential to address these challenges and provide targeted support to help the LDCs achieve the SDGs by 2030.

### **The Sustainable Development Goals (SDGs)**

**GOAL 1:** No Poverty- End poverty in all its forms everywhere

**GOAL 2:** Zero Hunger -End hunger, achieve food security and improved nutrition and promote sustainable agriculture.

**GOAL 3:** Good Health and Well Being - Ensure healthy lives and

promote wellbeing for all at all ages.

**GOAL 4:** Quality Education - Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.

**GOAL 5:** Gender Equality- Achieve gender equality and empower all women and girls.

**GOAL 6:** Clean Water and Sanitation - Ensure availability and sustainable management of water and sanitation for all.

**GOAL 7:** Affordable and Clean Energy- Ensure access to affordable, reliable sustainable and modern energy for all

**GOAL 8:** Decent Work and Economic Growth -Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all.

**GOAL 9:** Industry, Innovation and Infrastructure - Build resilient infrastructure, promote inclusive and sustainable

industrialization and foster innovation

**GOAL 10:** Reduced Inequalities- Reduce inequality within and among countries.

**GOAL 11:** Sustainable Cities and Communities - Make cities and human settlements inclusive, safe, resilient and sustainable.

**GOAL 12:** Responsible Consumption and Production- Ensure sustainable consumption and production patterns

**GOAL 13:** Climate Action- Take urgent action to combat climate change and its impacts.

**GOAL 14:** Life below Water - Conserve and sustainability use the oceans, seas and marine resources for sustainable development.

**GOAL 15:** Life on Land - Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forest, combat desertification and halt and reverse land degradation and halt biodiversity loss.

**GOAL 16:** Peace, Justice and Strong Institutions- Promote peaceful and inclusive societies for sustainable development provide access to justice for all and build effective, accountable and inclusive institutions for all.

**GOAL 17:** Partnerships for the Goals - Strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development.

### **Challenges in Implementing the Sustainable Development Goals in Least Development Countries**

Least Developed Countries face significant challenges in implementing the SDGs due to a combination of structural, economic, social and environmental factors. Some of the key challenges include:

#### **Limited Financial Resources**

LDCs lack the financial resources to invest in the SDGs with many relying on foreign aid to support their development efforts.

- **Lack of Funding:** LDCs often face considerable constraints that hinder their ability to fund SDG projects mostly due to their heavy reliance on

external aid, loans and remittances which may not always be steady or adequate.

- **Debt Burden:** Many LDCs are burdened with high levels of debt, which causes a limitation of their fiscal space for investments on sustainable development initiatives.
- **Debt Sustainability:** External debt stock levels of LDCs remain high and interest costs are expected to increase thereby crowding out spending on other priorities.

### **Weak Institutional Capacity**

Most LDCs struggle with weakness in governmental institutions, civil societies as well as in the private sector which has hindered the effective implementation of SDGs.

- **Governance and Institutions:** There is a marked incidence of limited technical expertise, poor administrative capacity as well as weak governance structures in LDCs that has resulted in their inability to implement and monitor SDG initiatives.
- **Corruption:** This is a major barrier to effective governance. Corruption

diverts resources meant for development and undermines trust in public institutions.

### **Lack of Innovation and Technology**

- **Limited Access to Technology:** LDCs often lack access to advanced technologies that could drive innovation, improve productivity and help address challenges related to climate change, agriculture and healthcare.
- **Digital Divide:** This is a significant challenge as access to the internet and digital tools is limited in LDCs which further deepens inequalities in education, job opportunities as well as access to services.

### **Conflict and Political Instability**

- **Political Instability:** LDCs are prone to political instability including armed conflict, civil unrest and authoritarian governance. All of which disrupt development efforts, displace populations and drain resources..
- **Fragility:** Conflict, fragility and insecurity significantly impede SDG implementation, usually redirecting resources from development

priorities to emergency response and recovery.

### **Lack of Data, Statistics and Monitoring Systems**

- **Data Gaps:** Reliable, timely and disaggregated data are crucial for monitoring progress on SDGs. However, many LDCs face difficulties in collecting and analyzing data due to limited technological capacity, financial constraints and weak institutions.
- **Monitoring and Evaluation:** The lack of effective monitoring systems in LDCs has posed significant difficulties in program assessments, identification of challenges as well as in policies and strategies adjustments.

### **Dependence on External Aid**

- **Aid Dependency:** The dependency of LDCs on foreign aid and international support to fund development projects often creates a dependency that undermines local ownership and long term sustainability of SDG initiatives.
- **Aid Volatility:** Shifts in Donors' agendas as well as in international priorities lead to the unpredictable

nature of Aid flows which consequently may disrupt the continuity of SDG projects.

### **Vulnerability to Climate Change and Environmental Degradation**

Most Least Developed Countries are highly vulnerable to climate change, which has also impacted and undermined their progress towards the SDGs. (IFAD Report, 2022)

- **Climate Vulnerability:** The frontlines of climate change issues are often dominated by LDCs, with many vulnerable to extreme weather conditions, sea level rise and desertification. These environmental stresses can reverse development and make it harder to meet SDG targets.
- **Loss of Biodiversity:** LDCs often lack the capacity to effectively manage and protect their rich natural resources and biodiversity, frequently leading to degradation.

### **Poverty and Inequality**

- **High Levels of Poverty:** A large proportion of the population in LDCs live in poverty, which creates a vicious cycle where key components

of the SDGs such as Education, Healthcare and Housing, become unaffordable to the people.

- **Inequality:** There is pervasive gender, ethnic and regional inequalities in LDCs, with certain groups having limited access to resources and opportunities making the achievement of inclusive growth and social development difficult.

### Education and Health Care Systems

- **Limited Access to Education:** LDCs face significant gaps in educational attainment, especially for girls, women and marginalized communities which leads to a limitation in human capital development -an essential ingredient for economic growth and sustainability.
- **Weak HealthCare Systems:** Progress on SDGs related to health and well-being is hampered by shortage of medical professionals caused by brain drain syndrome, inadequate healthcare infrastructure and poor access to essential medicines in LDCs.

### Global Market Challenges

- **Trade Barriers:** The ability of LDCs to generate income and invest in sustainable development is limited by their difficulty in accessing global markets due to trade barriers, tariffs and a lack of competitive industries.
- **Global Economic Shocks:** Global recessions, commodity price fluctuations as well as other economic shocks can have a disproportionate impact on LDCs through derailing progress on SDGs related to economic growth and poverty reduction.

### Trade and Investment Barriers

- **Market Access:** LDCs are often hindered from participation in global supply chains as well as from benefits accruing from international economic growth due to tariff and non tariff barriers to trade.
- **Private Sector Involvement:** Attracting Foreign Direct Investment (FDI) and fostering a competitive domestic private sector can be challenging in LCDs as a result of issues like political insatiability, weak infrastructure and regulatory uncertainty.

## **Cultural and Social Norms**

- **Cultural Resistance:** Most LDCs are fraught with contexts where cultural norms, religious beliefs or social practices can hinder progress, particularly on issues like gender equality, reproductive rights and the acceptance of new technologies.
- **Gender Inequality:** Many women and girls in LDCs face significant barriers to education, healthcare and economic opportunities which in turn limits their ability to contribute to and benefit from sustainable development.

## **Inadequate Infrastructure**

- **Poor Infrastructure:** LDCs often lack roads, electricity, sanitation, internet connection and other infrastructure that supports sustainable development. This directly affects development efforts to improve education, healthcare and economic growth.
- **Access to Clean Energy:** Progress on SDGs related to climate action, innovation and industry is prevented by the lack of access to reliable and

affordable energy that is experienced by most LDCs.

## **Opportunities for Implementing the Sustainable Development Goals in Least Developed Countries**

Despite the challenges, there are numerous opportunities that can help LDCs unlock pathways to sustainable development via the utilization of a multi-pronged approach.

## **Forge International Cooperation and Stronger Partnerships**

- **Global Partnerships for Development:** The SDG framework emphasizes the need for global partnerships. LDCs can benefit from international cooperation through initiatives like International Financial Aid, South-South Cooperation and Technical Support from developed countries as well as global organizations. These partnerships are geared towards the strengthening of **SDG 17**.
- **Climate Financing:** The Green Climate Fund and the Adaptation Fund are some of the specialized climate financing mechanisms that LDCs can leverage to finance climate-resilient infrastructure and



adaptation projects, thereby  
advancing **SDG 13**.

### **Youth and Human Capital Development**

- **Young Population:** With the right investment in education and skills development, the young population of LDCs can become a driving force for innovation, entrepreneurship and economic growth. Thus contributing to **SDG 4** and **SDG 8**.
- **Entrepreneurship:** Furthermore, the young people can be a powerful engine for innovation and entrepreneurship. The fostering of an entrepreneurial ecosystem can enable LDCs create new industries, reduce unemployment and contribute to **SDG 9**.

### **Leverage Technological Innovation and Leapfrogging**

- **E-Governance:** E-governance tools can improve transparency, increase government services efficiency and reduce corruption. Thereby allowing for a quicker realization of **SDG 16**.
- **Digital Transformation:** Digital technologies like mobile phones, internet connectivity, and digital

platforms can be utilized by LDCs to skip traditional infrastructure development stages and accelerate their rate of developmental progress. Examples of innovations that can directly contribute to **SDG 9** and **SDG 3** are Mobile banking, Telemedicine and E-learning.

### **Inclusive and Gender Responsive Development**

- **Empowering Women and Girls:** Gender inequality is a major issue in LDCs therefore empowering women in LDCs presents significant opportunities for economic growth and social development. Their productivity and overall well-being can be boosted by women's participation in the workforce, political leadership and entrepreneurship. Contributing to **SDG 5** and **SDG 10**.
- **Inclusive Policy-Making:** Marginalized groups like persons with disabilities, ethnic minorities, rural populations, etc in LDCs can benefit from development initiatives, thus fostering **SDG 1** and **SDG 10**.

### **Agricultural Transformation**

- **Sustainable Agriculture:** With the adoption of climate-smart agriculture, improving agricultural productivity and promoting sustainable land management practices, LDCs can improve food security, reduce poverty and ensure sustainable livelihoods. This contributes to SDG 2, SDG 12 and SDG 13.
- **Agri-Tech:** Progress on multiple SDGs can be driven by the use of technology in Agriculture such as precision farming, drones, mobile Apps for farmers, etc. All of which improves efficiency, reduces waste and enhances food security.

### **Green and Blue Economy**

- **Green Economy:** LDCs can invest in green industries like renewable energy, sustainable tourism and eco-friendly manufacturing. A green economy will not only create jobs but also improve environmental quality and contribute to **SDG 3** and **SDG 12**.
- **Blue Economy:** With their vast coastlines and marine resources which they can harness sustainably through the blue economy. most LDCs are favourably positioned to achieve **SDG 14** and **SDG 8**.

### **Access to International Development Finance**

- **Private Sector Investment:** The private sector can play a critical role in implementing the SDGs, particularly in areas such as infrastructural development and job creation.

With the right policies and incentives, LDCs can attract foreign Direct Investment (FDI) particularly in the agricultural and energy sectors.

- **Innovative financing mechanisms:** Green bonds and impact investing are some of the innovative financing mechanisms that can provide new sources of funding for the SDGs implementation in LDCs.
- **Concessional Finance:** LDCs have access to concessional loans and grants from multilateral development banks such as; World Bank and African Development Bank (AFDB). This financing option can support critical infrastructure projects, including those related to clean water, healthcare and education contributing to **SDG 6**, **SDG 3** and **SDG 4**.

### **Improved Health Systems and Universal Healthcare**

- **Health Innovation:** Health Innovations like mobile vaccination programs, telemedicine, mHealth, etc, can be utilized by LDCs to overcome infrastructure gaps and deliver essential healthcare services to remote area and thus contribute to **SDG 3**.
- **Universal Health Coverage:** By strengthening primary healthcare systems and expanding access to essential health services, LDCs can make progress toward **SDG 3**.

### **Decentralized and Community –Led Development**

- **Community Empowerment:** Decentralized development approaches can help LDCs empower local communities through decision making and allocating resources closer to the people. This can increase participation, enhance ownership and lead to more sustainable development outcomes.
- **Local Solutions for Local Problems:** Community-led infrastructure projects, health clinics,

education initiatives, etc are some of the local solutions that may prove more effective and responsive to the needs of the population while contributing to **SDG 11 and SDG 16**.

### **International Advocacy and Voice**

- **Raising Global Awareness:** By speaking out and advocating for their specific needs and challenges on global fora, particularly in the area of trade, finance and climate change. LDCs can also contribute to **SDG 17 and SDG 13** by building international alliances and making their voices heard.

### **Regional Integration and Trade**

- **Access to New Markets:** Improvements in their trade infrastructure and alignment with global standards can enable LDCs access larger markets. This will in turn boost LDCs exports and contribute to their economic development.
- **Regional Economic Integration:** LDCs can stimulate economic growth, reduce poverty, and achieve **SDG 8 and SDG 17** through regional trade agreements and regional

economic communities that promote intra-regional trade, reduce trade barriers as well as foster economic cooperation.

- **South-South cooperation:** South-South Cooperation can provide opportunities for LCDs to learn from each other and share best practices in implementing the SDGs.

### **Civil Society and Non-Governmental Organizations**

- **Civil society and Non-Governmental Organizations:** Civil societies and Non-Governmental Organizations can play a critical role in promoting the SDGs and holding LDCs governments accountable for their implementation.

### **Recommendation for Improving the Implementation of Sustainable Development Goals in Least Developed Countries**

In order to improve the implementation of the SDGs in Least Developed Countries the following recommendations may be considered:

**Local SDG Indicators:** Creation of tailored indicators that reflect the specific challenges and goals of each LDC, will allow for

targeted interventions that increases the rate of progress on SDG implementation.

**Increased Financial Support:** The provision of increased financial support to LCDs through innovative financing mechanisms can enable and maintain SDGs implementation.

**Strengthen Institutional Capacity:** The institutional capacity of LCDs must be strengthened, both in governments, civil societies and the private sector, to support the implementation of the SDGs.

**Enhance Local Governance:** Building of capacity at the local levels to ensure effective implementation of the SDGs through decentralized government structures.

**Participatory Policy-Making:** LCDs are encouraged to engage their local communities in decision making processes in order to ensure that policies reflect the needs and priorities of local populations.

**Promote Technological Innovation:** Technological innovation including the use of ICT is a very important method of supporting the implementation of the SDGs in Least Developed Countries.

**Foster International Cooperation:** The implementation of the SDGs can also be maintained through the fostering of

international cooperation and partnerships between the Least Developed Countries and Developed Countries.

**Improve Access to Quality Education:** LDCs should invest in free and quality education systems that focus on both formal and informal learning opportunities.

**Promote Digital Literacy Programs:** Programs aimed at increasing digital skills to prepare the workforce for a rapidly changing job market is one of the ways LDCs can enhance the implementation of SDGs.

**Support Small and Medium Enterprises (SMEs):** Provision of training, access to finance as well as technical assistance to help SMEs thrive and provide jobs will improve the ability of LDCs to implement SDGs.

**Sustainable Agricultural Practices:** The promotion of agro ecology and sustainable farming techniques to improve food security and livelihoods, help to ensure that SDGs are effectively implemented in LDCs.

**Universal Health Coverage:** Prioritizing funding and resource allocation for healthcare can help LDCs implement the SDGs.

**Community Based Natural Resource Management:** LDCs can empower local communities to manage and protect their

natural resources. This will in turn enable the rapid and sustained implementation of the SDGs.

**Investment in Renewable Energy:** LDCs should develop policies that promote renewable energy projects so as to enhance energy access and lower greenhouse gas emissions.

**Incorporation and Recognition of Indigenous Knowledge and Practices:** Integration of traditional ecological knowledge into sustainable development practices particularly in agriculture and biodiversity conservation assists LDCs in ensuring that the SDGs are implemented.

**Promotion of Sustainable Eco-Tourism Initiatives:** LDCs can develop eco-tourism initiatives that benefit local communities while conserving the environment and ensuring that revenues are re-invested locally.

**Supporting Cultural Diversity and Preservation:** Encouraging cultural heritage projects through investment in projects that promote the preservation of the cultural heritage of local communities, will allow LDCs accomplish SDGs implementation goals.

**Investment in Sustainable Cities:** Urban planning practices that prioritize green spaces, affordable housing and sustainable transportation options are some of the ways LDCs can achieve greater implementation of the SDGs.

**Establishment of Micro-finance Initiatives:** Through the creation of micro-finance institutions that empower entrepreneurs and small businesses via the provision of small loans and financial services, LDCs can achieve greater implementation of the SDGs.

**Social Safety Nets:** Establishing comprehensive social safety net programs in order to protect their vulnerable populations from economic shocks as well as to ensure basic living standards will enable LDCs achieve greater implementation of the SDGs.

**Foster Technological Innovations:** Supporting local start-ups and encouraging innovation hubs so as to create local solutions that address SDGs challenges such as health, education, agriculture etc, will help LDCs in implementing the SDGs.

**Collaborative Research Initiatives:** Promotion of knowledge sharing and collaborative research across borders to address transnational issues like climate

change, trade and health, will ensure that LDCs implement the SDGs.

**Support Civil Society Engagement:** LDCs are encouraged to provide support for civil societies' engagement and participation in the implementation of the SDGs through capacity building and funding.

**Encourage Private Sector Engagement:** Public –Private partnerships and impact investing are ways the private sector can participate in the implementation of the SDGs in LDCs.

**Promote South-South Cooperation:** Knowledge sharing between Least Developed Countries can support the implementation of the sustainable development goals.

**Improve Data and Statistics:** Improvement in Data and Statistics to support tracking the progress of Sustainable Development Goals implementation in Least Developed Countries is key.

**Build Capacity For Policy Implementation:** LDCs must build their capacity for policy implementation through training and request for technical assistance.

**Reduce Dependency on External Aid:** Reduced dependence on external aid by LDCs can be achieved through promoting

domestic resource mobilization and private sector development.

This will in turn enable LDCs make better progress towards achieving the SDGs.

**Empower Women and Marginalized Groups:** LDCs must ensure that their policies specifically address the needs and potential of women, youth and other marginalized groups.

**Public Awareness Campaigns:** LDCs must endeavour to conduct community based initiatives to raise awareness about the SDGs and their importance for local development.

**Youth Engagement Programs:** The involvement of young people in initiatives that promote entrepreneurship, social initiatives and environmental stewardship are some of the ways that LDCs can accomplish the task of SDG Implementation in their local communities

## **Conclusion**

The implementation of the Sustainable Development Goals in LDCs is critical to achieving the goals of ending poverty, protecting the planet as well as ensuring peace and prosperity for all.

While there are challenges to implementing the SDGs in LDCs, there are also significant opportunities for their advancement

including; international cooperation, innovative financing mechanisms, technological innovation, civil society and private sector engagement, South-South Cooperation, etc. Furthermore, by leveraging their natural resources, youthful populations as well as their potential for technological leapfrogging, LDCs can achieve significant progress on SDG implementation. Embracing inclusive, green and innovative development strategies can facilitate the progress of these countries towards implementing multiple SDGs. To improve the implementation of the Sustainable Development Goals in Least Developed Countries, it is recommended that financial support be increased, institutional capacity be strengthened, technological innovation be promoted, Civil Society and Private Sector engagement be encouraged and international cooperation be fostered. Also, LDCs must reduce their dependence on external aid while ensuring that they build capacity for policy implementation. The use of data and statistics must not be neglected.
