The Role of Church Leaders in a Pluralist Society

Abstract

In a pluralist society characterized by diversity in beliefs, values, and worldviews, the role of church leaders is pivotal in fostering dialogue, understanding, and cooperation among different faith communities. This paper examines the challenges and opportunities faced by church leaders in pluralist societies and explores strategies for effective interfaith engagement. Drawing on theological principles and practical examples, the paper argues that church leaders play a crucial role in promoting peace, tolerance, and mutual respect in a diverse society.

Introduction

In today's pluralist society, characterized by a multitude of faith traditions and worldviews, the role of church leaders is increasingly important in fostering interfaith dialogue, understanding, and cooperation. As spiritual guides and moral authorities, church leaders have a unique opportunity to promote peace, tolerance, and mutual respect among diverse religious communities. This paper explores the challenges and opportunities faced by church leaders in pluralist societies and examines the ways in which they can contribute to building a more harmonious and inclusive society.

Our descriptions of society should likewise be viewed to be attempts at highlighting or capturing the nature of the world we live in. There are many such descriptions. Examples of such descriptions are evident in the use of the following terms: humanistic, capitalist, socialist, liberal, collectivistic, and individualistic. One of the descriptions of society often used and employed at the beginning of the third millennium is "plural" or "pluralistic". Society is dynamic and as it changes people are called upon to use new or additional descriptions to indicate the major trends associated with the changes taking place. In such circumstances those institutions and communities with established traditions might have to reflect upon their relevancy and role with respect to the new trends or directions in their society. It is therefore natural for any community seeking to be effective and in step with its society to constantly ask itself whether the old ways of doing things are still relevant in the light of changes taking place.

The global pandemic closed houses of worship and brought religion indoors quite unexpectedly, through new, often demonized technologies. Paradoxically, the sacred has returned through rituals held online, on television, and in religious group chats, even though much research on religious socialization has shown that the role of the family in passing on religion is diminishing. Even if one wants to distance oneself from it, messages about distancing, about the management of places, and about the lack of care for the ritual of death, have inserted the themes and languages of religions into often-dry messages and daily news. Several studies reported a revival of prayer and religious participation during the pandemic, underscoring the still vital and effective link between religion and well-being (Kowalczyk et al. 2020; Upenieks and Ellison 2022; Jacobi et al. 2022; Bueno et al. 2023).

Two years after the pandemic, war returned to Europe, with the deployment of religious leaders and calls for shared values across religions in a general political debate occurring as far-right and nationalistic parties returned to power (Morieson 2021; Yilmaz 2023; Haynes 2020; Sadlon 2021). Religion is again intertwined with politics, entering the public debate and returning to the stage of international relations after the long wave of the French secularism debate reduced religion. The discussion of religious pluralism is also intertwined with the issue of ethnic minorities and the connection between identity, religion, and national belonging (Sadlon 2021).

The church is that spiritual organism of which Christ is the Head, composed of all regenerate people from Pentecost to Rapture. The growth and success of the early church mainly depended on the abilities of the church leaders. This was demonstrated by the powerful preaching of the gospel by Peter which lead to the conversion of 3000 people who joined the early church in a single day (Acts 2:41-47). It can be noted in scripture that the increase of church membership is the initiative of the Holy Spirit working through men, the tongues of fire that rested upon the disciples on the day of Pentecost was a theophany that came to impart a missionary purpose upon them. Eims (2008) narrates that it is the responsibility of the church leaders today and their congregants to carry out the mission of God in making him known to the world. Church leaders are responsible for the success or failure of a church. God holds leaders responsible for what takes place in the ranks. It is through responsible and able leaders that God keeps his people in the right direction. Without good leadership the vision and mission of a church cannot be achieved.

The main responsibility of church leaders is to influence others to work together willingly on related tasks to attain that which the organization desires. Before the modern concepts of leadership came into being, the apostle of Jesus Christ had their own styles of leadership to ensure sustainable growth and survival of the church and these has remained the model for the church for ages. The apostle entirely depended on the guidance of the Holy-Spirit from time to time. According to Benincasa (2015) leadership is a process of personal influence by which a leader shapes the attitudes and activities of others towards the attainment of the organizational objectives. Oluwasegun (2005) defines leadership as the ability to gain consensus and commitment to common objectives beyond organizational requirements. Further, James Koroma (2015) defines leadership as process by which a person influences others to accomplish an objective and directs the organization in ways that makes it move in a cohesive and a coherent manner. According to Dairo (2004) Leadership is the art of getting things done. It can be learnt, improved, developed and perfected. Leadership style is the way a person uses power to lead other people; the most appropriate leadership style depends on the function of the leader, the followers and the situation (Benincasa, 2015).

In essence Christian leadership has unchanging values and principals such as morality, servant hood, and respect for people but the style of leadership varies depending on the individual leader and the situation in which leadership is exercised. A well developed and mature leader has the

capacity to exercise different styles of leadership in different situations (Eims, 2008). In times of a crisis a lender may use an authoritarian style, while in a decision making situation the leader may call for consensus building. Whitney (2016) states that leadership styles are not fixed it is the situation that dictates which style can be used. Specific situations help leaders to determine the most effective style of interactions. Sometimes leaders must handle problems that require immediate solutions without consulting followers while in some occasions consultation is vital. As Brown (2008) concedes all things rise and fall on leadership, church interreligious relationship depends greatly on its leadership abilities.

Defining a Pluralist Society

Anything *pluralistic* involves a diversity of different ideas or people. A *pluralistic* society is a diverse one, where the people in it believe all kinds of different things and tolerate each other's beliefs even when they don't match their own. To establish a common understanding, this section will provide a concise definition of pluralism in the sociopolitical and religious contexts, drawing references from scholars like John Hick and Diana Eck.

Religious pluralism is defined as reconciliation of different beliefs. It indicates also an attempt at the level of a community of multi-religious habitation to live in peace and harmony. However the commonly accepted notion of religious tolerance of the minorities is not necessarily the spirit of religious pluralism. In fact, it is a kind of religious modernism and liberalism which not only prohibits religious persecution but also encourages the mitigation of the differences among different religions through debates and dialogues. It may also be viewed as a form of social obligations of the majority towards the minority. But, here again, the obligations do not belong to the majority alone; it also calls for equal or proportional response from the minorities. The question then arises as to what mechanism can ensure such pluralism to survive? Or to put it differently, how can the belief system of one religion be accommodated with another? The answer to these questions leads us to further involvements in the sense that various world religions have divergent beliefs which defy substantial reconciliation. The question is all the more perplexing when the moral and political structure or a particular religion poses serious threat to another religion.

Viewed as such, according to Legenhauhan in Eva (2011) we may assert that "Religious Pluralism" is also an attempt to provide a basis in Christian theology for tolerance of nonChristian religions.

John Hick the most celebrated proponent of this thesis has come up with very specific suggestions for implementation of Religious Pluralism. In his definition of religion he delineated universalism of all religion by acknowledging their diversity as various understanding of the same universe. In his analysis Hick (1989, p. 233) entered into details of the theoretical and doctrinal debates and controversies which, in his opinion, lead to a common goal, namely the common concept of the Divine or the Ultimate. Different religion arose in different societies to cater to different needs of those societies. In his own language: "... many different accounts of divine reality may be true though all expressed imperfect human analogies, but... none is the whole truth. May it not be that different conceptions of God, as Jehweah, Allah, Krisna, Paramatma, Holy Trinity, and so on; and likewise the different conceptions of Hidden Structure of Reality, as the eternal emanation of Brahman, or as an immense cosmic process culminating in Nirvana, are all Image of the Divine, and yet none by itself fully and exhaustively correspond to the infinite nature of the ultimate reality?"5 Religious Pluralism thus may be viewed as a recent innovation which seeks to provide a theological basis for tolerance in spite of diversities. Hick believes human beings imagine the divine through their respective cultural and individual mediation which results in the different concept of divine in different societies. Revelations received by prophets and sages at different times have been tested by long experiences of the followers and ritualized through long traditions of worships. It is therefore very likely that a genuine encounter with the divine reality will take multifarious forms.

Plurality of religion, in its essence is the plurality of religious tradition and culture. As a statement of objective conditions, Religious Plurality is a reality which exists in all countries and regions where there is multi-religious habitation. But as a theoretical exegesis it involves several contents and commitments which is characterized as Religious Pluralism. Diana L. Eck a renowned scholar of Religious studies in her elaborate analysis of the American society emphasized the need for a concerted effort to build up pluralistic societies in America as also elsewhere. In her opinion the response evoked by the people all over the world after every ugly incident of communal violence makes it clear that multi-religious and multi-cultural fabric is too strong to rend by random violence. In the backdrop of this analysis by Diana L. Eck the essential tenets of Religious Pluralism may be summed up in following terms: First, it is energetic engagement with diversity which essentially involves continuous communality and relationship dissipating tensions and

acrimonies. Second, it calls for active perusal of understanding across the lines of difference. This is significantly different from passive tolerance which is of course necessary for Religious Pluralism but not sufficient. Third, commitments to one's own religion are not loosened rather crystallized with increasing knowledge of each other's belief. Finally, Pluralism is based on dialogue leading to criticism and self-criticism. This does not mean giving away ones commitments to one's own Religion but taking an enlightened view of others beliefs.

The Church

The Church in the New Testament has two words derived from the Septuagint for church, *ekklesia* from *ek* and *kaleo* 'to call out' and 'synagogue', from sun and ago, meaning 'to call or bring together'. The latter is used extensively to denote either the religious gathering of the Jews or the buildings in which they assembled for public worship. The term *ekklesia*, however, generally designates the church of the New Testament, although at few places it denotes common civil assemblies (Berkhof 1958, pp. 556-557). The Greek word *ecclesia* refers to any assembly, it could be local congregation of believers or the universal body of all believers, and hence the statement 'where two or three are gathered in my name I (Christ) am in their midst' (Mt 18: 20).

Challenges Faced by Church Leaders in a Pluralist Society

Dealing with Religious Prejudice: This section will explore how church leaders combat religious prejudice within their communities, citing the research of Diana Eck and Maher Hathout.

The church had made impressive stride in improving the destinies of Nigerian citizens through the provisions of quality education, which, to a great extent, has transformed the Nigerian society; free gospel messages that have moulded the character of myriad of Nigerian citizens; and through the provision of reliable healthcare services that have saved many miserable indisposed people. Unfortunately, rewards for Christians' lofty contributions have been ruthless tortures, senseless killings and wanton destruction of their properties by jihadists. As has been mentioned earlier, at several occasions the government had collaborated with jihadists to frustrate church's efforts. Government confiscated properties belonging to the church by way of forceful takeover of mission schools and lands and expelling of expatriate missionaries in Nigeria immediately after the civil war. The worst is that successive federal governments since independence have not been fair to the church. Government has not sincerely protected Christians from these brutalities.

Obviously, in the words of Onyeidu (1999): Religion is handicapped where there is no freedom of [*sic*] worship or where the state is anti-religion. Religion needs freedom to operate effectively, especially in a multi-religious nation like Nigeria. (p. 21)

Normally, religious pluralism gives equal opportunities to different religions to function in a particular state. Thus, worshipers have the freedom to worship in their own liturgical way, without encroaching on the rights of other religion's worshipers of different faith. Every religious being is at liberty to worship in its way is guaranteed. Therefore, no force should be used in making converts, rather religious institutions must operate flexibly so that religious adherents could decide for themselves to practice religion of their choice.

The fact that Nigeria is a pluralistic society is the cause to believe that religious pluralism if given its proper place in Nigeria could avert inordinate and incessant religious conflicts. This should, however, not to be taken as a simplistic solution, given the fact that there is propensity for constant violence in a society where religious autonomy and freedom are recognised. In a pluralistic society, there would always be a potential for violence if religions claim the right to do mission work amongst others. This brings to the fore the imperativeness of Gandhi's assertion that education is incomplete without religion. It is through education and inter-faith dialogue that adherents would be made to understand that all religions have a common mission; hence, all religions are the same. Christians and indeed adherents of other religions in Nigeria are advised to educate their members

on the need to imbibe good virtues of religion and religious diversity whilst taking a series of expedient measures to improve their religion's fervour to serve humanity.

This is a mandate for God's church; thus, the church is tasked with being the agent and implementer of transformation not because of her will but because of God's plan for the world. Therefore, the involvement of believers (church) is something that is absolute as evidence of obedience to God through its existence in the midst of family, community, region and country. Church growth is the responsibility of all the body of Christ, namely the church itself. Wegner said: "Everything has to do with bringing people who are not yet in a relationship with Jesus Christ into fellowship with Him and into responsible church membership." Meanwhile, according to John Virgil: "church growth is a variety of manifestations or manifestations of the Great Commission of the Lord Jesus (Matt. 28:19-20; Mark 16:15; Luke 24:47-48; John 20:21; Acts 1:1) 8) to build churches (not buildings) in all kinds of growth." Based on the sources above, it can be categorized into two aspects; church growth increase/development of the number of members (quantity) and growth in the quality of faith (seen in terms of daily life). So, the role of the church must continue to exist and move simultaneously in its growth both in quantity and quality.
